Planning application AVA/2023/0108 French Horn Inn Nottingham Road – erection of new food store for Farm foods

This Public House has been empty for some time and whilst the Parish Council would prefer to see it continue as an inn, we are pleased that a possible new use is being pursued.

However, without a proper study and re configuration of the access and egress to the site, then Codnor Parish Council object in the most strenuous way to this new

application. It has obviously had vehicle movements there in the past but not as a retail outlet and without proper traffic management at this junction there will be serious accidents and long delays at the traffic lights. It may require there to be a totally new junction including a 5-way traffic lights system to incorporate the 3 main roads and the 2 business concerns. Will you please ensure that these major concerns are taken very seriously.

In addition, the Parish Council asks the Tree Officer to consider appropriate TPO's.
